

# OAS CAHPS Dates & Deadlines

This document will keep you informed of key deadlines for OAS CAHPS survey administration and data submission. Note that we recommend frequent “Update” files throughout the survey administration period, with the final update file deadlines for data submission displayed below. The update files should contain patient data required by CMS that were unavailable at time of upload and, therefore, were not included in your initial patient data files. Administrative data elements allow our system to determine survey eligibility for this program, so it is important for you to provide complete and accurate information in your files. As part of our commitment to you, Press Ganey performs periodic audits and will notify you of missing data required for OAS CAHPS. You will be alerted if less than 100% of your eligible patients have complete administrative data.

Press Ganey must be authorized by each HOPD/ASC prior to the data submission deadlines; otherwise, we are unable to submit data to the warehouse. [Instructions for vendor authorization](#) and other resources for the data warehouse can be found on <https://oascahps.org/>.

The Press Ganey InfoTurn Technical Transmission Instructions (ITTI) identifies the data fields required for OAS CAHPS. Every original and updated patient record must include the Survey Designator, Client ID and Unique Identifier. For additional information about “Update” files, please see the relevant portions of the ITTI.

\*To be compliant with sampling protocols, no more than 10% of your ambulatory surgery records can be missing CPTs by the 5th of the month two months following the procedure month (for example, January records must have CPTs populated by March 5<sup>th</sup>), so please make every effort to populate CPTs/G codes for each sample month by this deadline. If this 10% threshold is exceeded, a discrepancy report will be required.
