

Hospice CAHPS Dates & Deadlines

This Hospice CAHPS Dates & Deadlines schedule will keep you informed of data submission deadlines to comply with CMS public reporting. Send your patient data files and "update" files on a monthly basis to meet the deadlines provided in the schedule below. After the data submission deadline, we encourage you to access the data submission reports stored on the CAHPS Hospice Survey Data Warehouse and confirm your data has been successfully submitted.

As part of our commitment to you, Press Ganey will perform periodic audits and notify you of missing data required for Hospice CAHPS. Update files should be transmitted by the deadlines below and contain patient data required by CMS that was unavailable at time of initial upload.

Additionally, you are also required to provide a count for the total number of No Publicity patients excluded from the Hospice CAHPS file each sample month. This number should include those patients who requested not to have their name released. If you need additional information about this required count, please let us know.
